Notes to letter writer: Employees should send this letter to the right person, such as an immediate supervisor or ADA coordinator. Employees are not required by law to make a reasonable accommodations request in writing. Requests can be made orally. When an employee requests a reasonable accommodation in writing, the employee should keep a copy. [...]

**SAMPLE: Reasonable Accommodation Request Letter ...**

The defendant must provide a response stating whether he/she/it will comply with the request. Specific grounds or reasons must be given with some specificity explaining why the request for documents is overly broad or the reasons why having to produce the documents would be unduly burdensome.
